

BOMBAY PUBLIC TRUSTS ACT, 1950.

No. BPT. 1390/350/(81)-VI.—Whereas, under Government Notification, Law and Judiciary Department, No. BPT. 1390/350/(81)-VI, dated the 31st October 1991 (hereinafter referred to as "the said draft Notification") issued under the first proviso to sub-section (4) of section 1 of the Bombay Public Trusts Act, 1950 (Bom. XXIX of 1950) (hereinafter referred to as "the said Act"), the said draft notification which the Government of Maharashtra proposes to issue in exercise of the powers conferred by the first proviso to sub-section (4) of section 1, directing that the Indian Red Cross Society, Maharashtra State, Branch, 141, Shahid Bhagat Singh Road, Town Hall Compound, Bombay 400 023, a public trust registered under the provisions of the said Act, having Registration No. E-878 (Bombay) and its branches situated in the State of Maharashtra, registered as public trust under the said Act, shall, effect from the date of publication of this notification in the *Official Gazette*, be exempted from all the provisions, except those relating to registration contained in Chapter IV of the said Act, having been published as required under the second proviso to the said sub-section (4) of section 1 for inviting objections or suggestions from any persons likely to be affected by the said draft notification so as to reach the Secretary to the Government of Maharashtra, Law and Judiciary Department, Mantralaya, Bombay 400 032, on or before the 30th day of November, 1991 :

And Whereas, no objections or suggestions have been received from any person in respect of the said draft :


Now, therefore, in exercise of the powers conferred by the first proviso to sub-section (4) of section 1 of the said Act, the Government of Maharashtra hereby directs that the Indian Red Cross Society, Maharashtra State Branch, 141, Shahid Bhagat Singh Road, Town Hall Compound, Bombay 400 023, a public trust registered under the said Act as aforesaid and all its branches situated in the State of Maharashtra registered as a public trust under the said Act, shall, with effect from the date of publication of this notification in the *Official Gazette* be exempted from all provisions except those relating to registration contained in Chapter IV of the said Act.
